

CoppaFeel! Annual Survey

Bi-Annual Prize Draw

1. By entering The 'CoppaFeel! Annual Survey for healthcare professionals' bi-annual prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by CoppaFeel!.

Eligibility to enter

3. The prize draw is open to UK-only entrants who have completed the CoppaFeel! Annual Survey for healthcare professionals.
4. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim the prize (see section 10). CoppaFeel! reserves the right to check your eligibility before entering you into the draw.
5. A maximum of one entry per individual per year is permitted.
6. The prize draw is free to enter.

How to enter

7. To enter the prize draw, you will need to have engaged with CoppaFeel! services, resources and/or programmes relating to your role as a healthcare professional, during the respective 6 month period.
8. By completing the CoppaFeel! Annual Survey for healthcare professionals, the prize draw form and by giving your contact details via the form – either an email address and/or mobile number – you will be in with a chance of winning. Once you have submitted the prize draw form you will then be entered into the draw.
9. You will be entered into one of two annual prize draws which will take place in November 2024 and April 2025.
10. CoppaFeel! will not accept responsibility if the contact details provided are incomplete or inaccurate.

The prize

10. The prize will be a choice of one of the following:
 - 10.1. An Apple iPad up to the value of £300.
 - 10.2. A Love2shop Gift Card to the value of £300.
 - 10.3. A Ticketmaster Gift Card to the value of £300.
11. There is one prize each draw to be given away.
12. The prize is non-exchangeable, non-transferable and no cash alternatives will be offered.
13. We reserve the right to substitute prizes with another prize of equal or higher value if circumstances beyond our control make it necessary to do so.
16. The decision of CoppaFeel! regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
17. The winners will be drawn at random from all valid entries and recorded via Zoom with an independent observer present. This recording will not be shared publicly but retained as proof that the prize was allocated by chance.

Winner announcement

19. The winners will be notified on the first working day of the month via the details provided on the form submitted.
20. CoppaFeel! will attempt to contact the winners by email once. If only a phone number has been provided, CoppaFeel! will attempt to contact the winners by text once.
21. If the winner does not respond to the email/text notifying them of their win within 7 days of the first email/text attempt, they will lose their right to the prize, and CoppaFeel! reserves the right to choose and notify a new winner.

Receipt of the prize

22. On acceptance of the prize, CoppaFeel! will send you your gift card via email or arrange postage of the iPad, depending on the prize selected by winners.

Data protection and publicity

24. You consent to any personal information you provide in entering the prize draw being used by CoppaFeel! for the purposes of administering the prize draw, and for those purposes as defined within our privacy policy.

26. The first name of winners will be published on the CoppaFeel! website after acceptance of the prize and no later than 30 days following the prize draw.
27. The winner agrees to the release of their first name to any other prize draw participants if requested via CoppaFeel!.
28. All personal information shall be used in accordance with CoppaFeel!'s Privacy Notice.
