

## **CoppaFeel! Tempo ticket draw Terms and Conditions**

1. By entering the **CoppaFeel! Tempo ticket** prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by CoppaFeel!. CoppaFeel! is a registered charity in England and Wales (1132366) and Scotland (SC045970) & a company limited by guarantee (06974733). Registered office Unit 4, Bickels Yard, 151-153 Bermondsey Street, London, SE1 3HA
3. This competition is a free draw (all entries are free).

### **Eligibility to enter**
